

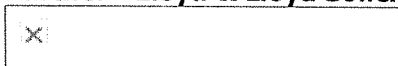
Dear Partners

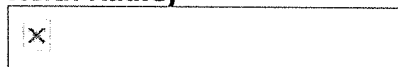
